**PACIFIC GAS AND ELECTRIC COMPANY'S  
REPLY TO PROTESTS AND RESPONSES**

On December 21, 2009, Pacific Gas and Electric Company (PG&E) filed Application 09-12-020 for a test year 2011 General Rate Case (GRC). This application appeared on the Commission's Daily Calendar on December 24, 2009. Pursuant to Rule 2.6 of the California Public Utilities Commission's Rules of Practice and Procedure, protests or responses were due 30 days later, or on January 25, 2010, and were timely filed by the Division of Ratepayer Advocates, The Utility Reform Network, the Alliance for Retail Energy Markets, the Consumer Federation of California, the Direct Access Customer Coalition, Equinix, the Greenlining Institute, the Independent Energy Producers Association, the Merced Irrigation District, the Modesto Irrigation District, the South San Joaquin Irrigation District, and the Western Power Trading Forum. This reply is timely filed within 10 days of the last day for filing protests and responses.<sup>1</sup>

In their protests and responses, several parties have made factual claims and set forth arguments with which PG&E does not agree. PG&E expects that the Commission will conduct hearings in this GRC. Further, PG&E anticipates that the parties filing protests and or responses will intervene in the case, submit testimony on the issues identified, or participate in the hearings. PG&E will respond, as appropriate, to all issues parties raise in their testimony or briefs that are within the scope of this case.<sup>2</sup> To the extent any issues may be reasonably settled or otherwise resolved, PG&E
