**ADMINISTRATIVE LAW JUDGES' RULING
SETTING PUBLIC PARTICIPATION HEARING FOR OCTOBER 1ST**

The Commission opened this multiphase investigation to consolidate and consider issues raised by the extended outages of Units 2 and 3 at the San Onofre Nuclear Generating Station (SONGS). Generally, we are focused on any warranted refunds to ratepayers or rate reductions. The Phase 2 evidentiary hearings on October 21-25, 2013 will consider the removal from rate base of non-useful capital assets at SONGS. Other phases of the proceeding have or will address other SONGS-related cost issues.

In consultation, assigned Commissioner Michel Peter Florio and Administrative Law Judges (ALJ) Melanie M. Darling and Kevin R. Dudney have

determined that it is relevant to this proceeding to hear from the public about how the Commission should adjust rates as a result of the non-operation of SONGS. Therefore, a Public Participation Hearing (PPH) focused on ratemaking issues related to the SONGS outage and retirement will be held as follows:

2:00 – 5:00 p.m. and 6:30 – 9:30 p.m.

The presiding ALJ will set the Agenda and determine speaking times. During the first hour of the PPH, local government representatives will be given priority for public comment. Members of the public who wish to address the Commission must sign in at the PPH and will be called upon in the order listed on the sign-in sheet. Community-based organizations and other groups are encouraged to identify one or two speakers to represent the views of the organization's members.

No later than 10 days after the date of this ruling, Southern California Edison Company and San Diego Gas & Electric Company shall each provide to the Public Advisor by e-mail, for review and approval, a draft customer notice of the PPH. The Commission's Public Advisor's Office (PAO) shall work with this Commission's News and Public Information Office and the Business and Consumer Outreach group to maximize notice to the affected public through a broad range of media and organizational contacts.

Written statements from the public will be accepted by the PAO.

Therefore **IT IS RULED** that a Public Participation Hearing is set for 2:00 to 5:00 p.m. and 6:30 to 9:30 p.m. on Tuesday, October 1, 2013 at the Al Bahr Shriners Building, located at 5440 Kearny Mesa Rd., San Diego, CA 92111.
